### **Target market summary**

The product is likely to be appropriate for a consumer seeking capital preservation and regular income by providing exposure to a portfolio of global and Australian bonds screened to exclude issuers with material exposure to fossil fuels or engaged in activities deemed inconsistent with responsible investment considerations, to be used as a core allocation, or small allocation, to fixed income within a portfolio where the consumer has a medium to long investment timeframe (3+ years), medium risk/return profile and needs daily access to capital.

The Fund is an exchange-traded product and is generally only available to consumers through the ASX.

### Investment products and diversification

A consumer (or class of consumer) may intend to hold a product as part of a diversified portfolio (typically with an intended product use of satellite/small allocation or core component). In such circumstances, the product should be assessed against the consumer's attributes for the relevant portion of the portfolio, rather than the consumer's portfolio as a whole. For example, a consumer may seek to construct a conservative portfolio with a satellite/small allocation to growth assets. 	the consumer's intended product use is Solution / Standalone, or		
	the consumer's intended product use is Core component and the consumer's risk (ability to bear loss) and return profile is Low.
